Haw River Trail Partnership MOU Renewed

The Haw River Trail Partnership was formed with the goal of helping the public enjoy and conserve the natural resources of the Haw River corridor. The Partnership is the result of a signed memorandum of understanding between eleven governmental agencies agreeing to work together for the development of trails along the river and the conservation of the river and lands within the watershed.

In March, the Haw River Trail memorandum of understanding was officially renewed through December 31, 2032. The following organizations are members of the Haw River Trail Partnership:

Haw River Trail Updates

Haw River Trail Authorized as State Trail

This spring, two bills were introduced in the NC General Assembly to authorize the Haw River Trail as a State Trail. Senate Bill 100 was introduced by Senator Amy Galey of Alamance County on February 14th and was also sponsored by Senator Natalie Murdock of Chatham County. A companion bill House Bill 124 was introduced by Representatives Stephen Ross and Dennis Riddell of Alamance County on February 15th and was also sponsored by Representative Robert Reives of Chatham County.

The bill was approved by the North Carolina General Assembly on May 31 and will now be sent to Governor Cooper for his signature. Next, the trail will be reviewed for designation after completion and inspection by a state trail planner and the NC Trails Committee.

In addition to giving the trail more status and marketing recognition, this designation means the

Department of Natural and Cultural Resources "shall support, promote, encourage, and facilitate the establishment of trail segments" and "the State may receive donations of appropriate land and may purchase other needed lands for the Haw River State Trail".

The planned Haw River Trail corridor extends approximately 80 miles along the Haw River from Haw River State Park on the Rockingham-Guilford County line through Alamance County to Jordan Lake State Recreational Area in Chatham County. The HRT is part of the state-wide Mountains-to-Sea Trail (MST) which allows hikers to travel across the state from Clingman's Dome to Jockey's Ridge. Approximately 40 miles will pass through Alamance County once complete.

Alamance County Friends of the Mountain-to-Sea Trail Task Force • Spring Update



Volunteers from the Alamance County Task Force of the Friends of the Mountain-to-Sea Trail have completed a reroute of the Haw River Trail/ Mountains-to-Sea Trail. Construction of the new trail started in early September 2022 and was completed on February 20, 2023. The reroute runs between Carolina Mill and Copland Mill, along Carolina Mill Road close to the east bank of the Haw River. The new reroute will allow hikers to avoid crossing Carolina Mill Road and Carolina Road and provide a more intimate experience with the river.

The Alamance County Task Force spent six months building the reroute, with a total of 1,185 volunteer hours contributed. This section of trail was difficult to clear since parts of it are located on the steep riverbank of the Haw which was covered with dense vegetation. The Task Force also removed a lot of trash that had accumulated along Carolina Mill Road.

In March, the Alamance Task Force began work in Saxapahaw on a new trail going north on the west side of Saxapahaw Dam, which will eventually connect with existing HRT/MST at Longmeadow Trail Parking Lot in Graham. Work on this trail will continue throughout the spring and summer.

Cotton Mills of the Haw River: Carolina Cotton Mill

George W. Swepson bought a mill site from Joseph Trollinger in 1865, and resold it to the Holt family in 1866. Edwin Michael Holt's sons: James Henry Holt and William Erwin Holt, opened Carolina Cotton Mills in 1869, which by 1996 was operating with 3,073 spindles and 58 looms. The mill originally produced blue denim, though Alamance plaids were added later.

A wood frame dam with stone abutments was constructed in 1868 measuring about 200 feet long and six feet high. A millrace approximately three-quarters of a mile long was dug which provided a fall of 15 feet at the mill, where 150 horsepower was generated. The mill was expanded in 1904 to contain 8,000 spindles and 500 looms, making it one of the largest cotton mills in Alamance County. A steam generator was also installed in 1904 to provide power when water flow was inadequate to maintain operations.

On the hill behind Carolina Mill are the remains of a residential community and commercial buildings, which at one time constituted 35 structures. The former mill's water tank is located in the middle of Carolina Mill Road.

The dam was destroyed prior to 1950 and the mill was

closed by 1960 and all the houses were privatized. The property is now owned by Carolina Mill LLC, a subsidiary of Capital Broadcasting in Raleigh, North Carolina.

The Haw River Trail/N.C. Mountains-to-Sea Trail crosses the Carolina millrace below the Highway 61 bridge at Glencoe and follows it to the back of Carolina Mill, alternating between running on top of the millrace and following next to the Haw River.
